





The county says the farm had too many people on the hayride and did not follow social distancing protocols in waiting lines.


















#### **COVID-19 GUIDELINES FOR YOUR VISIT**

- . MASKS must be worn at all times on the farm.
- · REFRESHMENTS will not be available this season.
- SANTA LETTERS. Letters to Santa may be mailed at our farm. Letters should already be written. A writing area will not be available this year.
- PETS are permitted as long as they are on a leash at all times. To comply with social distancing guidelines, pet owners are asked to refrain from allowing others to pet your furry friend.




